



HOUSEHOLD INCOME, EXPENDITURE AND CONSUMPTION DURING THE FIRST QUARTER OF 2011

Household Income

The average quarterly total income average per household member during the first quarter of 2011 is 868 Levs or by 2.1% less compared to the same quarter of 2010. The main part of this income is received from wages and salaries and pensions. A nominal and relative decrease in wages is registered. The tendency of increase in pensions persists in similar terms as noted in comparative analyses from past periods. The relative share of household income from wages and salaries is 85.8%.

Wages and salaries continue to be the main source of household income. During the first quarter of 2011 it is 459 Levs per capita or by 1.3% more compared to the first quarter of 2010. The relative share of wages and salaries within the total income increases from 51.1% to 52.9% or by 1.8% more compared to the first quarter of 2010.

The second important source of household income is the income from **pensions**. The relative share of pensions within the total income increases by 1.5% and becomes 32.9%. During the first quarter of 2011 it is 285 Levs per capita or by 2.5% more compared to the first quarter of 2010.

The income from **entrepreneurship** decreases during the first quarter of 2011 compared to the first quarter of 2010 by 5.8%, it is 44 Levs per capita and the relative share within the total income decreases slowly by 0.2% and it is 5.1%.

The weight of **other social incomes** during the first quarter of 2011 is relatively insignificant in the total household income. During the period this income decreases by 40.4% and becomes 44 Levs per capita, the relative share decreases by 1.8% and becomes 2.7%.




Figure 1. Structure of the total household income during the first quarter of 2010 and 2011

The relative share of **monetary income** into the total income during the first quarter of 2011 is similar in comparison with the same quarter of 2010 and it is 99.1%.





Household Expenditure

The total expenditure per household member during the first quarter of 2011 is 775 Levs and it increases by 1.4% in relation to the same quarter of 2010. Expenditure on food and housing (energy, fuel and water) has the greatest share in forming the total expenditure and constitute 52.2% of total expenditure.

The most significant part in the household budget is expenditure on **food and non-alcoholic beverages**. As absolute values it is 284 Levs average per household member during the first quarter of the year, represents 36.6% in total expenditure and increases by 0.5% in comparison with the same quarter of the last year.

The expenditure on water, electricity, heating and furnishing for the compared quarters decreases from 147 Levs to 140 Levs per capita; the relative share also decreases - by 0.1% and it is 18.1% in total expenditure.


The expenditure on **health** decreases by 7.8% during the first quarter of 2011 in comparison with the first quarter of 2010 and becomes 45 Levs per capita, which represents 5.8% in the total expenditure and decreases by 0.5% in comparison with the first quarter of 2010.

The expenditure on **transport and communication** decreases by 2.6%, it is 81 Levs per capita as absolute values during the first quarter of 2011, the relative share decreases from 11.0% to 10.5%.

The expenditure on **alcoholic beverages and tobacco**_is 32 Levs per capita during the first quarter of 2011, which relative share of the total expenditure is 4.1% or 0.5% less compared to the first quarter of 2010.

The expenditure on **clothing and footwear** decreases by 6.3% and it is 18 Levs per capita during the first quarter of 2011, which represents 2.3% of the total expenditure or 0.2% less compared to the first quarter of 2010.

Figure 2. Structure of the total household expenditure during the first quarter of 2010 and 2011








Household Consumption
