

TRIPS OF BULGARIAN RESIDENTS ABROAD AND ARRIVALS OF VISITORS FROM ABROAD TO BULGARIA IN MAY 2012




Figure 1. Trips of Bulgarian residents abroad by months

In May 2012 **the number of the trips of Bulgarian residents abroad** was 348.4 thousand or by 5.0% more than in April and by 4.6% above the registered in May 2011 (Figure 1). An increase in the total number of the trips of Bulgarian residents compared to the same month of the previous year was registered to: France - by 46.6%, FYROM - by 30.8%, Serbia - by 26.8%, Italy - by 19.6%, the United Kingdom - 9.8%, and etc. At the same time the greater decrease was observed to: Turkey - by 5.8%, Greece - by 1.3% and Romania - by 1.1%.

The trips with professional purpose composed the greatest share of the total number of trips of Bulgarian residents abroad - 38.3%, followed by the trips with holiday and recreation purposes - 34.6% and with other purposes (as guest, education and visit the cultural and sport events) - 27.1%. The trips with holiday and recreation purpose rose by 59.3%, while a decrease in the trips with other and professional purposes was registered - by 22.8 and 1.3% respectively.

In May 2012 the trips with professional purpose formed 61.7% of all trips to Germany, 58.4% - to Greece and 54.2% - to Italy. Predominated share of the trips to FYROM and Serbia was with holiday and recreation purpose - 54.3 and 53.9% respectively of all trips of Bulgarian residents to these countries, while 61.6% of trips to Turkey were with other purposes.








Figure 2. Structure of trips of Bulgarian residents abroad by purpose of visit and by countries in May 2012



In May 2012, **the number of arrivals of visitors from abroad to Bulgaria** was 605.9 thousand which was by 31.2% more compared to April, but with 4.6% below the level from May 2011 (Figure 3). A decrease in the visit by all observed purposes was registered, as the greatest was the drop in the visits with holiday and recreation purpose - by 8.4%, followed by these with professional purpose - by 3.0% and with other purposes - by 1.1%.





In May 2012, the arrivals of visitors from EU Member States decreased by 8.6% in comparison with the same month of the previous year. A significant decrease was observed in the visits of the citizens from Germany - by 19.9% and the United Kingdom - by 16.3%. However a growth in the visits from Belgium - by 7.0% and Austria - by 6.3% was registered.

The visits of foreigners in the group "Other European countries"¹ increased by 3.5% as the highest growth was observed from Russian Federation citizens - by 17.1%.

In May 2012 the visitors with holiday and recreation purpose composed the greatest relative share of the total number of foreigners visited Bulgaria - 42.6%, followed by the arrivals with other purposes (including as guest and passing transit) - 41.1% and with professional purpose - 16.3%.

The visits with holiday and recreation purpose formed 72.6% of the arrivals from FYROM, from Serbia - 62.7%, from Russia - 61.3% and from the United Kingdom - 61.2%. The visits with professional purpose were 40.7% of all arrivals from Italy, while with other purpose were 74.3% of the arrivals from Turkey and from Ukraine - 59.1%.

Group of "Other European countries" include countries in Europe outside EU.






Figure 4. Structure of arrivals of visitors to Bulgaria from abroad by purpose of visit and by countries in May 2012



Methodological notes

Statistical data on the trips of Bulgarian citizens travelling abroad and visits by foreigners in Bulgaria are obtained on the basis of monthly information received from the Ministry of Interior and sample survey of the National Statistical Institute among Bulgarian and foreign citizens passing the border check points.

Data on the number of the trips of the citizens of the European Union are estimated on the basis of the information obtained from the Ministry of Interior and the airport authorities. Data on the number of citizens of "third countries" are obtained directly from the Ministry of Interior.

Data on the purposes of the trips are developed on the basis of the NSI's regular monthly sample survey of passing Bulgarian and foreign citizens on the border check points.
