



TRIPS OF BULGARIAN RESIDENTS ABROAD AND ARRIVALS OF VISITORS FROM ABROAD TO BULGARIA IN JUNE 2012




Figure 1. Trips of Bulgarian residents abroad by months

In June 2012 **the number of the trips of Bulgarian residents abroad** was 361.3 thousand or by 3.7% more than in May 2012 and by 9.9% above the registered in June 2011 (Figure 1). An increase in the total number of the trips of Bulgarian residents compared to the same month of the previous year was registered to: Spain - by 122.8%, Italy - by 112.9%, FYROM - by 68.9%, Austria - by 42.0%, and etc. At the same time the greater decrease was observed to: Serbia - by 28.4% and Greece - by 16.0%.


The trips with other purposes (as guest, education and visit the cultural and sport events) composed the greatest share of the total number of trips of Bulgarian residents abroad - 40.2%, followed by the trips with holiday and recreation purposes - 34.9% and with professional purpose - 24.9%. The trips with holiday and recreation purpose, as well as these with other purposes rose by 65.2% and 23.2% respectively, while a decrease in the trips with professional purposes was registered - by 33.1%.

In June 2012 the trips with other purposes formed 63.7% from all trips to Serbia, 56.6% - to the United Kingdom and 52.6% - to Italy. Predominated share of the trips to Spain and Turkey was with holiday and recreation purpose - 43.2 and 42.1% respectively, while to Russia and Germany they were connected with professional purpose - 42.5 and 42.0% respectively of all trips of Bulgarian residents to these countries.




Figure 3. Arrivals of visitors from abroad to Bulgaria by months

In June 2012, the number of arrivals of visitors from abroad to Bulgaria was 1 116.6 thousand which was by 84.3% more compared to May 2012 and by 5.5% above the level from June 2011 (Figure 3). An increase in the visit by all observed purposes was registered, as the greatest was the growth in the visits with professional purpose - by 8.3%, followed by these with holiday and recreation purpose - by 7.4%, and with other purposes - by 0.8%.

The visits of the citizens of European Union composed the greatest relative share of the total number of foreigners visited Bulgaria - 56.9%, followed by these from the other European countries - 33.3%. In comparison with the same month of the previous year the arrivals of visitors from EU Member States decreased by 3.6%. A significant decrease was observed in the visits of the citizens from Greece - by 14.9% the United Kingdom - by 11.4% and Austria - by 10.9%. However a growth in the visits from the Netherland - by 14.8% and Italy - by 14.6% was registered.

The visits of foreigners in the group "Other European countries" increased by 25.1% as the highest growth was observed from Ukraine and Russian Federation citizens - by 60.5 and 34.1% respectively.

In June 2012 the predominated share of the total number of the visits to Bulgaria were with holiday and recreation purpose - 60.4%, followed by the arrivals with other purposes (including as guest and passing transit) - 29.6% and with professional purpose - 10.0%.

The visits with holiday and recreation purpose formed 81.0% of the arrivals from Russia, 79.6% - from Ukraine, 78.3% - from the United Kingdom, 75.3% - from FYROM and 71.8% - from Greece. The visits with professional purpose were 22.7% of all arrivals from Belgium and 20.3% - from Austria, while with other purpose were 81.6% of the arrivals from Turkey.



Methodological notes

Statistical data on the trips of Bulgarian citizens travelling abroad and visits by foreigners in Bulgaria are obtained on the basis of monthly information received from the Ministry of Interior and sample survey of the National Statistical Institute among Bulgarian and foreign citizens passing the border check points.

Data on the number of the trips of the citizens of the European Union are estimated on the basis of the information obtained from the Ministry of Interior and the airport authorities. Data on the number of citizens of "third countries" are obtained directly from the Ministry of Interior.

Data on the purposes of the trips are developed on the basis of the NSI's regular monthly sample survey of passing Bulgarian and foreign citizens on the border check points.
