

BULGARIAN TRADE WITH EU FOR THE PERIOD JANUARY - MARCH 2014 (PRELIMINARY DATA)

In the period January - March 2014 Bulgarian exports to the EU increased by 0.1% compared to the corresponding period of the previous year and amounted to 6.2 Billion BGN (Annex, Table 1 and 2). Main trade partners of Bulgaria were Germany, Italy, Romania, Greece, France and Belgium which accounted for 72.5% of the exports to the EU Member States (Annex, Table 3).

In March 2014 the exports to the EU increased by 0.1% compared to the corresponding month of the previous year and amounted to 2.2 Billion BGN.





Figure 1. Nominal value¹ change of exports of Bulgaria to EU for the period 2013 – 2014


Bulgarian imports from the EU in the period January - March 2014 increased by 6.1% compared to the corresponding period of the previous year and added up to 7.3 Billion BGN at CIF prices (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from Germany, Romania, Italy, Greece and Spain (Annex, Table 3).

In March 2014 Bulgarian imports from the EU Member States increased by 6.7% compared to the corresponding month of the previous year and amounted to 2.5 Billion BGN at CIF prices.

The **foreign trade balance** of Bulgaria (export FOB - import CIF) **with** the **EU** in the period January – March 2014 was negative and added up to 1 141.7 Million BGN (Annex, Table 1). At FOB/FOB prices (after elimination of transport and insurance costs on imports) the trade balance was also negative and amounted to 809.2 Million BGN.

In the first three months of **2014** compared to the corresponding period of the previous year the largest growth (49.2%) **in the exports** of Bulgaria **to** the **EU** distributed according to the Standard International Trade Classification (Annex, Table 4) was recorded in the section "Animals and vegetable oils, fats and waxes". The most notable fall was recorded in sections "Mineral fuel, lubricants and related materials" (35.6%) and "Crude materials, inedible (except fuels)"² (23.8%).

In **imports from** the **EU** the largest growth (20.4%) was reported in section "Animals and vegetable oils, fats and waxes" while the most notable fall (14.4%) was observed in section "Crude materials, inedible (except fuels)".
