




## BULGARIAN TRADE WITH THIRD COUNTRIES IN THE PERIOD JANUARY - SEPTEMBER 2015 (PRELIMINARY DATA)

In the period **January - September 2015** Bulgarian **exports to third countries** increased by 2.4% compared to the corresponding period of 2014 and amounted to 12.3 Billion BGN (Annex, Table 1 and 2). Main trade partners of Bulgaria were Turkey, China, Serbia, Russian Federation, Singapore, USA and Former Yugoslav Republic of Macedonia, which accounted for 55.1% of the exports to non-EU countries (Annex, Table 3).

**In September 2015** exports to third countries decreased by 17.1% compared to the corresponding month of the previous year and amounted to 1.277 Billion BGN.

(Compared to the same month of the previous year)**




**Bulgarian imports from third countries in the nine months of 2015** decreased by 5.8% compared to the corresponding period of 2014 and added up to 13.9 Billion BGN (at CIF prices) (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from the Russian Federation, Turkey, China and Ukraine (Annex, Table 3).

**In September 2015** Bulgarian imports from third countries decreased by 25.7% compared to the corresponding month of the previous year and amounted to 1.426 Billion BGN.

**The foreign trade balance** of Bulgaria (export FOB - import CIF) **with third countries** in the period January - September 2015 was negative and added up to 1 601.3 Million BGN (Annex, Table 1). The trade balance at FOB/FOB prices (after elimination of transport and insurance costs on imports) was also negative and amounted to 626.2 Million BGN.

**In September 2015** the foreign trade balance of Bulgaria (export FOB - import CIF) with third countries was negative and amounted to 149.1 Million BGN.

In the nine months of 2015 compared to the corresponding period of 2014 in the exports of Bulgaria to third countries distributed according to the **Standard International Trade Classification** the largest growths were recorded in the section 'Animals and vegetable oils, fats and waxes' (78.4%) and 'Miscellaneous manufactured articles'<sup>2</sup> (42.3%) (Annex, Table 4). The most notable fall was reported in section 'Mineral fuel, lubricants and related materials' (17.7%).

In imports from third countries the largest growths were reported in sections 'Food and live animals' (34.8%) and 'Animals and vegetable oils, fats and waxes' (21.3%) while the most notable fall was observed in section 'Beverages and tobacco' (26.4%).




## Bulgarian trade with third countries and EU - total

In the period **January - September 2015** the value of **all exported goods** from Bulgaria amounted to 34.0 Billion BGN and compared to the corresponding period of 2014 the exports increased by 6.6% (Annex, Table 1 and 2).

In September 2015 the total exports added up to 3.767 Billion BGN and decreased by 3.9% compared to the corresponding month of the previous year.

The total value of **all the goods imported** in the country **in the period January - September 2015** amounted to 38.1 Billion BGN (at CIF prices), or by 1.2% more than the corresponding period of 2014 (Annex, Table 1 and 2).

In September 2015 the total imports decreased by 12.3% compared to the corresponding month of the previous year and added up to 4.096 Billion BGN.

The **total foreign trade balance** (exports FOB - import CIF) was negative in the period January - September 2015 and amounted to 4 110.1 Million BGN which was 1 628.6 Million BGN less than the balance in the nine months of 2014 (Annex, Table 1 and 2). At FOB/FOB prices (after elimination of transport and insurance costs on imports) in the period January - September 2015 the total foreign trade balance was also negative and amounted to 1 548.8 Million BGN.

In September 2015 the total foreign trade balance (exports FOB - import CIF) was negative and added up to 329.0 Million BGN. The trade balance at FOB/FOB prices was negative and amounted to 100.4 Million BGN.
