




TRADE IN GOODS OF BULGARIA IN 2019 - FINAL DATA

In 2019 the **goods exported** from Bulgaria amounted to 58 459.4 Million BGN or 4.3% more than in 2018 (Annex, Tables 1 and 2). In comparing monthly data for 2019 with data for the corresponding month of the previous year the highest growth in exports was observed in February (18.4%), while the most notable fall was registered in June (5.1%).

In the **exports** of goods from Bulgaria, distributed according to the **Standard International Trade Classification**, in 2019 compared to 2018 the largest growth was reported in section 'Food and live animals' (14.0%). The most notable fall was observed in section 'Manufactured goods classified chiefly by material' (9.5%) (Annex, Table 4).



The imported goods in 2019 were for 65 989.9 Million BGN (at CIF prices)¹ which is 5.0% more than the previous year (Annex, Tables 1 and 2). Analyzing the monthly data on imports in 2019 and the corresponding ones in 2018, the biggest increase was observed in February (17.1%). The biggest decrease was registered in June (6.4%).

In the imports of goods to Bulgaria, distributed according to the **Standard International Trade Classification**, in 2019 compared to the previous year the largest increase was registered in section 'Beverages and tobacco' (24.8%) while a decrease was observed only in section 'Crude materials, inedible (except fuel)' (6.1%).

Foreign trade balance (exports FOB - import CIF) was negative in 2019 and amounted to 7 530.5 Million BGN (Annex, Tables 1 and 2).






Trade in goods of Bulgaria with the EU

In 2019 the **exports** of goods from Bulgaria to the **EU countries** increased by 2.8% compared to the previous year and amounted to 38 755.4 Million BGN (Annex, Tables 1 and 2). Main trade partners of Bulgaria were Germany, Romania, Italy, Greece, France and Belgium which accounted for 66.5% of the exports to the EU (Annex, Table 3).

In the exports of goods from Bulgaria to the EU, distributed according to the **Standard International Trade Classification**, in 2019 compared to 2018 the largest increase was registered in section 'Beverages and tobacco' (19.0%) (Annex, Table 4). The most notable fall was observed in section 'Manufactured goods classified chiefly by material' (4.5%).



The **imports** of goods to Bulgaria from the **EU countries** in 2019 increased by 3.1% compared to 2018 and amounted to 41 157.9 Million BGN (Annex, Tables 1 and 2). The most significant amounts were reported for the goods imported from Germany, Italy, Romania, Greece and Spain which represent 56.0% from the imports from the EU.

In the imports of goods from the EU, distributed according to the **Standard International Trade Classification**, in 2019 compared to the previous year the largest growth was registered in section 'Beverages and tobacco' (28.0%), while the biggest decrease was observed in section 'Crude materials, inedible (except fuel)' (16.5%).

Foreign trade balance (exports FOB - import CIF) of Bulgaria with the **EU countries** in 2019 was negative and amounted to 2 402.5 Million BGN (Annex, Table 1).






Bulgarian trade in goods with third countries

In 2019 the **exports** of goods from Bulgaria to **third countries** increased by 7.5% compared to the previous year and added up to 19 704.0 Million BGN (Annex, Tables 1 and 2). Leading trade partners of Bulgaria were Turkey, China, Serbia, the United States, the Russian Federation and Republic of North Macedonia, which accounted for 50.6% of the total exports to non EU countries (Annex, Table.3).

Figure 5. Nominal value¹ change of exports of goods from Bulgaria to non EU countries in the period 2018 - 2019




The **imports** of goods to Bulgaria **from third countries** in 2019 increased by 8.1% compared to 2018 and amounted to 24 832.0 Million BGN (Annex, Tables 1 and 2). The largest amounts were reported for the goods imported from the Russian Federation, Turkey, China, Egypt and Serbia whose share amounted to 66.4% of the total imports from non EU countries.


