



TRIPS OF BULGARIAN RESIDENTS ABROAD AND ARRIVALS OF VISITORS FROM ABROAD TO BULGARIA¹ IN OCTOBER 2020




Figure 1. Trips of Bulgarian residents abroad by months

In October 2020, during the continuing epidemic situation in the country, **the number of the trips of Bulgarian residents abroad** was 493.1 thousand, or by 4.2% above the registered in October 2019 (Figure 1).




Figure 2. Arrivals of visitors from abroad to Bulgaria by months

In October 2020, the number of arrivals of visitors from abroad to Bulgaria was 419.1 thousand (Annex, Table 1) or by 45.3% less in comparison with October 2019 (Figure 2). A collapse in the trips with all observed purposes was registered: 'holiday and recreation' - by 67.7%, 'professional' - by 57.7% and 'others' (including as guest and passing transit) - by 22.5%. Transit passes through the country were 53.1% (222.6 thousand) of all visits of foreigners to Bulgaria.

The share of visits of EU citizens was 44.7% of the total number of foreigners' visits to Bulgaria in October 2020 or by 53.1% less in comparison with the same month of the previous year. A drop in the visits of citizens from all observed countries was registered.

The visits of foreigners in the group 'Other European countries' decreased by 30.9%.



In October 2020, the relative share of visits by purpose was as follows: with other purposes - 64.4%, with holiday and recreation purpose - 21.1%, and with professional purpose - 14.5% (Figure 3).

Methodological notes

The definitions recommended by the World Tourist Organization and the Methodological manual for tourism by Eurostat are applied by the National Statistical Institute.

In accordance with these definitions, **an international tourist** is any person who travels to a country other than his/her permanent residence for less than a year and whose main purpose is not doing any activity for payment in place visited.

The purposes of visiting a country are the following:

- Excursion, holiday or entertainment (visits to cultural or historical landmarks, sport events and other);
- Visiting friends and relatives;
- Professional purposes (business trips, participation in conferences, congresses, concluding deals, and etc.);
- Other (education, medical treatment, and etc.) purposes.

In October 2020, due to the impossibility to conduct the statistical survey at the border checkpoints, all statistical data on the trips of Bulgarians abroad and the visits of foreigners in Bulgaria - total and for the purpose of the trip - were provided to the NSI by the Ministry of Interior.
